a) Village Shop

As discussed in public speaking, MT confirmed that there was an open meeting organised for 10am on 18th May at Village Hall

b) Hinkley C tour

MT reported that she went on the Hinkley C tour. At present there isn't very much to see in terms of buildings being constructed. Although in 6 months' time a visit will probably show a lot more. To book a visit an individual only needs to go down to the EDF showroom and you can self-book a tour; there is no need to go as part of an organised group.

5. Roads and Footpaths:

a) Update on previously reported items

i) Traffic count River Road

The clerk received the following response from Highways when enquiring about the traffic count equipment that had been seen on River Road

"Thank you for your email regarding traffic count equipment. This is not anything that Somerset County Council have requested and there's been no section 50 application for a third party to put out equipment either.

Would it be possible for someone from the Parish Council to take a look at the box at the end of the loops and note any company name and telephone number and we will contact them and issue the S50 application?"

Unfortunately, as the equipment has now been removed, it wasn't possible for the information requested to be obtained

ii) Pot hole opposite hairdresser

This has been inspected by Highways and will be repaired within their 28 day requirement

b) Access road running alongside the Green

WB has met with J Cox (contractors) and requested that 2 quotes be prepared for consideration by the PC - 1 for patching & 1 for an entire resurface. WB to forward the quotes to Members for discussion at next meeting

c) Any other matters relating to roads and footpaths in the parish

Temporary closure of Chapel Road from the junction with Quantock Rise, northwestwards for a distance of 93 meters to enable BT Openreach to undertake D Pole project work. The Order becomes effective on 18 June 2019. The works are expected to last for 3 days (09.30 - 15.30hrs).

b) Possible planning breaches in the parish

i) Updates on previously noted concerns

1) Crematorium lighting

The clerk reported that she had spoken to the crematorium manager. He confirmed that there were no lighting conditions or restrictions placed when any of the planning permissions were granted. The police have had to attend the crematorium during the night and have requested that either the main gates are left unlocked (so that their vehicles can access the area or overnight lighting is in place if officers have to inspect the area on foot). All the lighting is controlled on one circuit, so it is not possible to have some lights on and some off

2) AW spoke with The Elms Garage last Friday in regard to vehicles again parking on the grass verge. The garage explained that the cars that are parked southward are not the cars that the garage are selling, but are builders' vehicles that are completing the building works that permission was granted for last year. The building work is now complete and the garage assured AW that they understood the issue and wouldn't park their own vehicles on the verge.

• The PC had received a complaint regarding the recent fireworks in the village. Councillors agreed that this is not a PC matter nor does the PC have any powers to act in this matter.

Councillors resolved to give the clerk a budget of £2000 (inc VAT) to purchase a suitable laptop, necessary software, A3 colour laser printer, laptop bag and mouse, and the authority to research and complete the purchases between meetings
