

# PAWLETT PARISH COUNCIL

## Public Speaking Time: Topics raised

- *Pilgrims Way – concerns regarding the loss of privacy to the rear of some properties*

The chairman confirmed that Stonewater's boundary was to the right of the path and that the path is adopted by Somerset Highways, therefore the boundary is the property of Pilgrims Way properties. These are part owned by Sedgemoor DC who have inspected the situation – their assessment is that what is there is satisfactory. Several residents have erected their own screens. A resident has written to SDC asking that the issue be clarified as it is felt that it was originally assessed as a maintenance, rather than security, issue.

- *Footpath to the west of Springfield Close – there was a footpath to the hedge shown on the original plans. Now there is no path shown on the plan - where is it now?*

R Winter welcomed all present and explained that the planned Q & A session concerning the development at Springfield Close had to be postponed until January as Stonewater were unable to field a representative. All the original questions submitted would still stand and any additional questions should be submitted to the clerk no later than 1 week before the January meeting.

## 108. Minutes of the Parish Council Meeting held on 21<sup>st</sup> November 2016

## 109. Matters Arising:

### a) Springfield Close

The Chairman reported:

- He had originally been informed that the ditch running along Chapel Road would be re-instated. However, it has now been signed off by Highways and deemed not necessary due to the additional gullies installed.
- The keys had now been given to the new residents. Some parking, associated with people moving in, had been taking place on Chapel Road but the comments being posted on social media about this were not helpful and people should try and be more charitable during this period
- Hedging had been planted along the pavement and trees planted behind the houses

### b) Christmas Tree on the Green

The tree was erected at the beginning of December and has received many favourable comments from residents. The new stand has proved very substantial and resistant to a vandalism attempt. The lights switch on was well attended – Chairman suggested that for next year the school was approached to design a poster advertising the switch on with the winner turning on the lights. Councillors agreed that this was a good idea

Carols were held around the tree on 17<sup>th</sup> December and attended by over 100 people

##### **a) Consider Planning Applications**

###### **i) Consider Planning Application 41/16/00014. 23 Gaunts Road, Pawlett TA6 4SF**

*Erection of a two-storey detached dwelling, formation of parking and access*

After clarification from the agent prior to the meeting regarding the width of the access splay councillors could see no problems with the application and resolved it had no objection to the application

###### **ii) Re-Consider Planning Application 1/41/16/00013 in light of new information received from Somerset County Council**

*Construction of Waste Transfer Station with plant and machinery for bulking of waste for onward transfer, including steel portal framed building, hard standing, parking and staff facilities*

The clerk had received correspondence from Somerset County that Virador had agreed, in light of the Parish Council's concerns, to amend their application to retain the opening hours already granted (7am-8pm). Taking this amendment into account, Councillors resolved to withdraw their previous objection. The clerk was also requested to question the effectiveness of the wheel cleaning mechanisms for vehicles leaving the site in light of the issue raised in item 109 c)

#### **114. Roads and Footpaths**

##### **a) Trees on the edge of the Green**

The Clerk reported that Sedgemoor Tree Services had been booked to carry out the resonance testing. The chairman reported that he had planted some walnuts off the tree on the Green, which were sprouting, so if the trees did need to be felled there would be replacements available from the original stock.

##### **b) Lippitts Lane**

The chairman reported that he had spoken with the Rights of Way Officer. As a registered path, Highways are responsible for its upkeep and have spent nearly £1000 on the recent top dressing. It was hoped that walkers would use the centre of the track that had been repaired and horses and vehicles the two edges but already the repairs have been damaged and are not proving effective.

##### **c) Fingerposts**

The Chairman has looked at the post and it appears to be structurally sound. Parish Council resolved to paint the post, following the guidelines issued by Somerset CC, but to delay until better weather next year.

###### **i) Parking on newly hatched area Old Main Road / Gaunts Road**

It was noted that vehicles were regularly parked in this area, causing a hazard to other road users and pedestrians. Councillor reported that they had spoken to the individual concerned but to no effect. The Chairman offered to speak to the Police Officer responsible for Pawlett in the hope that a more official request to desist would be responded to.

#### **115. Sundial on the Green**

The chairman passed around a photograph showing an example of what was proposed which councillors agreed was most suitable. Due to the absence of W Barnard no pricing for the scheme had been presented, so the project was deferred to be concluded at the January meeting. H Smith raised her concerns that the project had run on and was not yet fully resolved so close to the required completion date

#### **116. Consider Additional Dog Waste Bins at River Road**

Currently, in addition to the official Parish Council Dog Waste Bins in the parish, there were 4 private bins that had been provided by a resident. The resident had requested that the bin at River Road be replaced by an official bin as it was often subject to large sacks of accumulated dog waste being dumped alongside it.

Councillors felt that this was beyond the 'intended spirit' of the bin and constituted fly tipping which could be reported to Sedgemoor DC to investigate if it persisted. It was felt that resources should be focused on the centre of the village. It was resolved to ask the resident to take down the bins he has kindly provided and the Parish Council will install two more official bins, one each end of 'The Drein' which runs from the Green.

#### **117. Consider ID cards for Parish Councillors**

C Clark had discovered that had been a coat of arms issued to a Baron who owned Pawlett in the past – if not subject to copyright, maybe this could be included on the card? R Winter reported he would bring samples to the next meeting for Councillors to discuss.

#### **118. Community Land, Chapel Road**

Following the decision of the Development Committee to award the land to Pawlett Parish Council, Sedgemoor DC have written to Mrs Parish, the land owner, to request that the transfer of ownership of the land, as laid out under the s106 agreement, commences.
