**18.12** Roads, Footpaths, River – Somerset Rivers Flood Action Plan. Clerk is attending a presentation from SRA on Tuesday 9<sup>th</sup> January, and will then respond to the consultation. Jason Bell has trimmed the hedge on the A38 behind Old Main Road, awaiting invoice. Still waiting for Highways to install the new streetlight on Chapel Road, Clerk will chase again. Possibility of Liam Gill instructing pathway cut A38 from OMR to garage, Clerk will make the request.

Lengthy discussions took place regarding the proposed Saltmarsh creation on Pawlett Hams by EDF, which will involve the compulsory purchase of 850 acres of parishioners' land. The Clerk will attempt to obtain hard copies of the proposal without paying the £50 fee. There is a landowner meeting in The Orchard Pub on the 22<sup>nd</sup> January 2024 at 7.30pm, where representatives from EDF and other authorities will be present to answer questions. There is then a drop in session at Pawlett Village Hall on Tuesday 30<sup>t</sup> January from 4pm to 8pm hosted by EDF.
